

**Stuart Kaye** was appointed to a Chair in Law at the University of Melbourne in 2006. Prior to that, he was the Dean of Law at the University of Wollongong from 2002 to 2006, and Head of School at James Cook University Law School from 2001-2002. He holds degrees in arts and law from the University of Sydney, winning the Law Graduates' Association Medal, and a doctorate in law from Dalhousie University. He is admitted as a Barrister of the Supreme Courts of New South Wales, Tasmania and Queensland, and of the High Court of Australia.

Professor Kaye has a research interest in the law of the sea and international law generally, and has published extensively in these areas. He has written a number of books including *Australia's Maritime Boundaries* (2<sup>nd</sup> Edn, 2001), *The Torres Strait* (1997), *Human Rights in International and Australian Law* (with R. Piotrowicz) (2001), and *International Fisheries Management* (2001). He was appointed by Australia to the International Hydrographic Organization's Panel of Experts on Maritime Boundary Delimitation in 1995 and in 2000 was appointed by Australia to the List of Arbitrators under the 1991 Madrid Protocol to the Antarctic Treaty. He was made a Fellow of the Royal Geographical Society in 2007.

Professor Kaye is the current Chair of the Australian International Humanitarian Law Dissemination Committee. He has undertaken consulting work for government and industry, including the Australian Departments of Defence, Agriculture, Forestry and Fisheries, Finance, Environment and Heritage and Geoscience Australia, Ausaid, the Canadian International Development Agency, the Canadian Department of Fisheries and Oceans and the Commonwealth Secretariat. He has presented papers in Australia, New Zealand, Canada, the United States, the European Union, southern Africa, the South Pacific and South East Asia. He appeared for the Government of Tasmania in constitutional litigation in the High Court of Australia in *Grain Pool of Western Australia v Commonweath* (2000) 202 CLR 479.

**Toni Lucev** is a Federal Magistrate of the Federal Magistrates Court of Australia. He was sworn in as a Federal Magistrate on 15 August 2006.

Prior to becoming a Federal Magistrate Toni was a barrister. He joined the independent bar in Western Australia on 1 April 1999 and practiced initially at Francis Burt Chambers and later at John Toohey Chambers. He practiced primarily in industrial relations and employment law, but also in intellectual property, liquor licensing, worker's compensation and insurance law. In January 1992, Ken joined the independent bar at what is now Francis Burt Chambers, practising in most areas of commercial litigation. Ken was appointed a QC in March 1997 at the age of 41 years. He served as President of The Law Society of Western Australia, during 2001. Ken was Deputy Chair of the Legal Practice Board between 2002 to 2004 and was the Chair of the Admissions Committee of the Legal Practice Board between 2002 and 2005.

Ken is currently Deputy Chair of the Legal Practitioners Complaints Committee. He was President of the WA Bar Association between December 2005 and November 2007. He is a Director of WA Bar Chambers Ltd, the operating company of Francis Burt Chambers and of the Law Council of Australia. He was recently elected to the 5 person Executive of the Law Council of Australia. He is a member of the Law Society of Western Australia's Law Mutual Strategic Management Committee and the Chair of its Claims Committee.

Ken served as a Commissioner (ie acting Judge) of the District of Western Australia for a period in 1996 and served two terms as a Commissioner of the Supreme Court of Western Australia in 1999 and 2005.

Ken was a coach at the Australian Bar Association's (ABA's) week long residential Advocacy Courses in Perth (January 2007), Sydney (January 2008) and the Barossa Valley (July 2008).


Following his return from Japan in 2007, Warwick has been involved in the commercial and technical aspects of Woodside's shipping requirements for its Pluto LNG Project.

Simon attends the IMO Marine Environmental Protection Committee as an NGO delegate for the IMarEST, principally involved in OPRC and HNS matters and the implementation of National Contingency Plans, but was also involved with Marpol implementation and amendments. He has been a member of various MEPC OPRC Working Groups, Drafting Groups and Technical Groups. On behalf of the IMarEST he personally wrote the IMO Foundation course for Response to Marine Oil Spills, which was approved at the 2004 MEPC.

For a number of years Simon has carried out IMO training in response to marine oil spills around the world and in recent years has specialised in HNS pollution prevention and response training having completed his HazWoper diploma and NIIMS command training at Texas A&M University.

For the past four years he has chaired the ISO Standards sub-committee working group that deals with marine pollution matters. He also chairs the UK Environment Industries



Commission marine oil pollution working group. He is a Hereditary Baron, a Freeman of the City of London and a Liveryman of the Worshipful Company of Shipwrights.

He was elected a Senator of the UK Engineering Council in 2000/2 and President of the Institute of Marine Engineering, Science and Technology (IMarEST), the largest institute of marine professionals in the World in 2002/3, he is Vice Chairman of the Wales Branch of the IMarEST. In 2004 he was one of a number of maritime professions nominated to the IMO Council for the annual award of IMO Person of the Year.

Simon has led DV Howells now Braemar Howells since 1987 to becoming the worlds first ISO 9001 accredited incident and pollution response, consultancy, training and contracting organisation. He originated the Marine Pollution Salvage Centre (The MPSC) located in Milford Haven, to become the home of the UK Government's MCA tier 3 At Sea pollution and oil recovery and salvage equipment stockpile and the UK's National HNS response capability, with teams of Braemar Howells staff on call 24/7 as required worldwide.

Simon is currently involved in the establishment, building and operation of MARPOL waste reception facilities in the major ports throughout Nigeria, which is an ironic return to his early career, as his first spill was in Apapa in 1978.
